Contract Terms

BOOKINGS: To secure and schedule services, a signed contract is required with a \$100 deposit due at the time of signing. The deposit is non-refundable and non-transferable. In the event the contracted Makeup Artist is unable to perform services agreed upon due to an emergency, illness, act of God, or unexpected occurrence, the deposit will be refunded.

DELAYS: A late fee of \$25 will be charged for over 30 minutes of delay when a client is late for a scheduled time or if scheduled makeup exceeds allotted time because of client delays.

SERVICE AND LOCATION REQUIREMENTS: Location of service for the day-of-event will be at the discretion of the client. A set-up table/work area needs to be made available for the Makeup/Hair Artist at said location. Ample lighting, whether by means of natural light or by lamps is necessary for services to be performed properly. If hair services are provided, all members must have their hair completely dry. Service will be forfeited and payment for slot time will be expected regardless of if service has not been provided.

TRAVEL FEE: A mileage and setup/pack up fee of \$30 will be charged for locations outside of Kausar's studio. Locations requiring travel beyond 40 miles from Kausar's studio require an additional travel fee which will be discussed upon consultation.

LIABILITY: All brushes and makeup products are kept sanitary. All products are sanitized between every makeup application.

PAYMENT: The final balance is due on the day of the event as one whole payment when Makeup Artist arrives—no exceptions. The person(s) responsible for the entire balance of payment is the person(s) who has signed the contract.

CANCELLATION POLICY: Cancellation must be made 7 days prior to your reserved date or you will be responsible for the full amount of services agreed upon in this contract. Deposit is non-refundable.

Artist Responsibilities

- All makeup products and tools are cleaned and sanitized between event bookings
- All hair tools and makeup supplies will be provided by the artist

Client Responsibilities

- Client must provide a mirror, chair, and table or space for work area
- Client must have accessible and functional electrical wall outlets
- For hair services, all clients must have hair completely dried and free of moisture. Unless separate service is booked, blow drying is not included part of hair services and deposit is non-refundable
